**Start Time: 6.30 a.m. handlers meeting. First dog on field 6:45 a.m.**

**Open:** International Style, approximately 400 yard outrun, lift, fetch, drive, cross-drive, shed and pen. Two one-day trials August 28<sup>st</sup> & 29<sup>nd</sup>. Course may be shortened if heat is excessive.

**Awards: \$2,000 per day plus Overall Champion and Reserve Champion award**

**Location:** Seven Springs Ranch, 10879 Buckhorn Rd., Glide OR.

**Entry Fee** \$55 per dog per day

**Two dog limit, third dog may be accepted if space permits.**

**Handlers BBQ Dinner at the Loft at Seven Springs Saturday August 28<sup>th</sup> cost \$12**

Sheep will be commercial cross-bred lambs. Sheep Replacement Cost \$150

I-5 Roseburg exit 124 (“To Hwy 138 Diamond Lake / Glide”). Follow signs through Roseburg to Diamond Lake / Glide (Hwy 138 East). Drive approximately 5 miles on Diamond Lake Blvd. Turn right at the **Dixonville** sign. This takes you to **Buckhorn Rd.** Proceed east (left) on Buckhorn Rd. Go about 8.6 miles. Trial field is on the right. past the Seven Springs Ranch Driveway Do Not go up the Seven Springs Ranch Driveway. The trial field is PAST the Seven Springs Ranch Driveway on Buckhorn Rd on the right.

Day parking at trial field. Camping next door to trial field, about 500 yards from trial field. – No hook ups
